



## Six Star Snow Riders (SSSR) Sponsor A Trail Program

### AGREEMENT

#### TERMS AND CONDITIONS

##### 1. PURPOSE

SSSR is a volunteer led, non-profit organization committed to protecting the environment, the health and safety of trail enthusiasts and volunteers, in the communities where we operate. Funds generated by this program help keep trails open and support club operations.

##### 2. PARTICIPATION IN SPONSOR A TRAIL PROGRAM

Only individuals, groups, or companies determined by SSSR will be allowed to sponsor a section of trail and must agree to the following:

- A. SSSR may refuse to grant a request to sponsor a section if, in its opinion, granting the request would jeopardize the program, be counterproductive to its purpose, create a public safety hazard, or be in conflict with OFSC, provincial or municipal policies.
- B. Program Participants are not considered as Officers, Employees, or Agents of SSSR.
- C. Program Participants shall indemnify SSSR and agree to abide by SSSR's guidelines and to not hold SSSR responsible for any injuries or damages that they may cause or suffer as a result of participation in the program.

##### 3. AGREEMENT

##### 4. SIX STAR SNOW RIDERS RESPONSIBILITIES

SSSR will:

- With SSSR approved art work, supply and erect two (2) weather-resistant signs (approximately 12"x18") with the company or individual's / groups' name displayed at each end of the sponsors sections of trail. (based on availability)
- Replace damaged or removed signs within a reasonable time frame, to a maximum of 2 signs per season.
- Monitor to ensure the objectives of the program are being met.
- Post on its website the sponsor's name next to the assigned section of trail
- Trail sections are first come first served (See website for locations)

**5. MODIFICATION/RENEWAL/TERMINATION/ OF THE AGREEMENT OR PROGRAM**

The SSSR Sponsor A Trail agreement or program may be modified in scope, or altered in any manner, at the discretion of the SSSR. Participants will have the option of renewing their agreement, subject to the approval of SSSR.

SSSR may terminate the agreement and/or remove the Sponsor A Trail signs bearing the participants name if it finds that they are not meeting the Terms and Conditions of the Agreement; there is an undesirable effect (such as vandalism, sign theft, environmental harm, or contravenes OFSC, provincial, or municipal guidelines or laws).

No refunds will be issued.
